Charlottetown Ringette Annual General Meeting Minutes Tuesday, May 24th, 2017

Attendance & Approval of Minutes

The minutes were reviewed by all in attendance, Chrissy Cooper motion the minutes be passed, Mark MacLeod second, all in favor.

New Business

Kerrilynn McInnis Memorial Scholarship

President's Report

Mike James reports there was an increase in registration and number of teams from the previous year. There was new equipment purchased that was needed because of the increase in registration numbers and a few pieces of equipment that needed to be replaced. Over all it was a great successful year. Mike motion his report be passed, Lauren Murphy second, all in favor

Treasurer's Report

Angela Malone reports that there is: \$31,000.00 in the bank, \$15,000.00 in GIC, \$58,000.00 in total assets, Total Revenue \$148,000.00, Total Expenses \$185,000.00, Charlottetown Tournament net income \$24,000.00, Power Rings net income \$4,800.00. The budget was off on ice rentals because of the increase in membership numbers more ice time needed to be purchased. There was more equipment bought jerseys, rings and shot clocks. Angela motion her report be passed, Carol Murphy second, all in favor.

Registrar's Report

Carol Murphy reports there were 392 house league players registered, 3 registrations were from kid sport. Up 5% in membership numbers from the year before. Online registrations and e-transfers worked great. Carol motion her report be passed, Denise Bain second, all in favor.

Ice Scheduler Report

Mike Devine reports there was a significant increase in hours, Crapaud ice times came in on a regular schedule and practice and game time increased. Goaltending Development Program took place and there was an increase in the gym ringette. The hours were disbursed very close to even between teams, some may have had a bit more because of the teams that were successful in moving on in the playoffs. Coaching Director Report

Mark MacLeod reports, this was a great year, all thirty coaches did a great job on and off the ice. I want to see them back with all smiles on their faces and ready to go next year. Mark motion his report be passed, Lauren Murphy second, all in favor.

Goaltending Development

Derek reports there was 9-10 hours of ice time. There was usually an average of 10-12 goalies, mostly U8 & U10. Senior goalies came to help out on the sessions and there was either a challenge getting shooters or too many shooters showed up. Mike motion his report be passed, Angela Malone second, all in favor.

Referee Report

Chrissy Cooper and Neisha Fisher report, the year went very well, and I think everyone was overall pleased with the officiating. There are times we are struggling for referees, so we like to keep encouraging all playing levels in the Charlottetown Ringette Community to consider the Officiating Course. U8/U10 Coordinator

Kerri Moore reports, Charlottetown Ringette had 45 kids take part in the Come Try Ringette event in Charlottetown on September 17th. The day's event ran smoothly and the kids all had a great time. This past season, Charlottetown Ringette had one U6 team (21 players), three U8 teams (15 players per team) and seven U10 teams. Feedback from parents and coaches were all positive. Ice time was probably the main concern as it is each year. The U8 coaches would like to see more game times available for their teams. The U10's were able to implement skating practices at the end of the season by utilizing Georgetown and Morell rinks. The feedback was very positive, and we would like to see this continue into the 2017/2018 season.

All eleven teams took part in tournaments and jamborees throughout the season. The Lollipop Tournament in Montague (November) kicked off the season for the U6's and U8's. All seven U10 teams took part in the separate Montague Tournament (November 17-20th). Our own Charlottetown Tournament (Jan 12-14th) say both the U8 and U10 teams participate. A small Jamboree was help for the U6 and U8's in Georgetown (March 4th) to close out their season.

The Riverview/Dieppe Tournament (March 10-12th) saw three U8 and seven U10 teams travel over to participate. And all seven U10 teams participated in the Year End Jamboree Day (April 2nd) held in Pownal. Kerri motion her report be passed, Mike Devine second, all in favor.

Web Communications

Lauren Murphy reports, the website continues to work as our main way of communication to the membership. Sponsorship program is to cover the cost of the website and advertising. Three new sponsors, Y's Men's Club, Bulletproof Solutions, MacPherson Roche Smith. Facebook (348 likes) up from 298 likes in 2016, and Twitter (453 followers) up from 335 in 2016. Online registration for house league was done through our website, and team registrations were taken for the Ch'town tournament, this proves to be the easiest way to manage all registrations. This year we only accepted online registrations for Power Rings camp. Lauren motion her report be passed Mark MacLeod second, all in favor.

Equipment

Denise Bain reports, overall it was a good year. Two new sets of jerseys were purchased (U12 red and U16 orange) to accommodate growing numbers. Two sets of pads and two blockers were purchased. It is difficult to know what size inventory of pads to maintain as the needs change yearly. More youth size blockers are definitely needed. Miscellaneous equipment purchased this year included cones, a set of pinnies, 4 ringette masks and first aid kits. The old first aid kits were dated and missing essentials such as bandages and dry ice packs. These should be checked yearly to ensure they are properly stocked. Ringette is alive and doing well in the Charlottetown area with growth in all divisions from U8 right through to the 18+ past season.


Here are a few highlights of the past season:

Website and Communications / Public Relations Coordinator

Website traffic gathered over one year from May 27, 2017 through May 27, 2018 saw 285,806 page views where the majority of traffic appeared in the month of October with 94,436 page views. The active time of year for the website is between September through end of March. June 6, 2017 through May 27, 2018 there has been 183 Facebook postings reaching 125,019 people. We have a total of 525 page likes which is an increase of 176 from May 2017. The largest post receiving the most amount of reach was 10,200 for Come Try Ringette posted in February. Twitter has a total of 489 followers. From May 2017, through May 2018 we saw 86,341 impressions where 53,900 came from January alone with 162 tweets - due to the Charlottetown Tournament.

There were just under 100 internal correspondence messages sent out to the membership and 34 Facebook private message conversations dealing with various topics.

Overall, it has been a very busy year on the website as we transitioned to a mobile friendly template which is easier to view on the phone. We've accounted for 9,857 unique users viewing the website on their phone over a one-year span with peak in October and January representing the registration period and Charlottetown Tournament.
